

## Instructions for filling up the Application Form for admission to B.Tech / /B.Pharm /BHMCT /BFAD /BFA under

### Kashmiri Migrants Quota

1. Application under Kashmiri Migrant quota can be made for admission to Govt. aided / Self financed/ Private Institutions affiliated to Dr. APJ Abdul Kalam Technical University, Lucknow in B.Tech. /B.Pharm /BHMCT /BFAD /BFA etc as per AICTE norms.
2. Direct admission to Kashmiri Migrants in first year in each institute is to be made as per the latest instructions of AICTE and orders from U.P. Govt. Such admissions will be over and above the sanctioned intake and normally limited upto one admission per Institute affiliated to AKTU, Lucknow. The candidates, opting for admission under this scheme, need not appear in UPCET-2021/JEE-2021 etc..
3. Candidates seeking admission under this quota must have obtained a minimum of 45 % marks in qualifying subjects at 10+2 level or equivalent examination. The subject combination required in the qualifying examination (intermediate examination of U.P.Board or 10+2 level examination or its equivalent) for admission to first year of different courses shall be as follows:

4. The last date for applying online at <https://upcet.admissions.nic.in/> is September 10, 2021 upto 05:00 PM.
5. Applications without declaration of 10+2 result or incomplete applications in any respect will not be considered.
7. The shortlisted candidates for counseling will be displayed on the website <https://upcet.admissions.nic.in/> on September 11, 2021.

8. The date of counseling of the shortlisted candidates is September 14, 2021 at Dr A.P.J. Abdul Kalam Technical University Uttar Pradesh, Sector 11, Jankipuram Extension, Lucknow (U.P.)-226 031.
9. The candidates are advised to see the notice showing candidates shortlisted for counseling on the website <https://upcet.admissions.nic.in/> before reaching the counseling centre on scheduled date/time for counseling.  
The counseling letter will NOT be sent to the candidates separately.
10. At the time of counseling, the candidates have to submit three latest passport size color photographs and their original documents along with one set of photocopies of following:
  - a. Marksheet of 10+2 or equivalent examination
  - b. High School (10th Std) Certificate
  - c. Proof of claimed quota
  - d. Bank drafts of Rs 5000/= as initial fee and Bank draft of Rs 1000/= as counseling fee in favor of Finance Officer, Dr A.P.J. Abdul Kalam Technical University Uttar Pradesh, Lucknow payable at Lucknow.
11. Candidates seeking admission in more than one course under Kashmiri Migrant quota must fill separate application forms for each course (B.Tech / B.Pharm/ or (BHMCT/BFAD/BFA together))
12. The latest Government orders up to the date of counseling shall be applicable for admission in Kashmiri Migrants quota.
13. The candidates are advised to keep on visiting the website <https://upcet.admissions.nic.in/> regularly and act accordingly. The notices placed on the website shall be treated as served to the candidates.
